Dear Mr. Lebovic,

We are writing to you with exclusive news of a new world-first achieved by UHN's Transplant Program thanks to your generosity and support.

On Saturday, November 25th, we performed the world's first kidney transplant in which we repaired a donor kidney outside of the body (*ex vivo*) before transplanting it into a patient. You saw an example of *ex vivo* kidney repair firsthand when you visited our laboratory several years ago. Your support is helping our Program to launch a world-first clinical trial to evaluate the safety and feasibility of this technique, developed and optimized at UHN and building on our global leadership and success in *ex vivo* lung and liver repair. Over the next year, the *ex vivo* kidney perfusion protocol will expand to repair damaged donor kidneys that could not otherwise be used, making them suitable for transplantation into patients. This will significantly increase the number of lives that can be saved through kidney transplantation and has the potential to double the number of kidney transplants worldwide.

We are delighted to report that the patient is recovering well following his surgery and had already returned home less than a week after his surgery. We wanted you to be the very first to hear about this important milestone for our Program that you have helped to make possible.

All of us at UHN would like to thank you once again for your exemplary support, which has fueled our team's progress from the laboratory to the clinic, and is saving and transforming lives every day.




